He has also defended a prominent hotel corporation in a sexual harassment case and advised the hotel on its employment discrimination policies. He has represented Washington, D.C. universities in race discrimination matters, including the successful defense of a reverse race discrimination case.

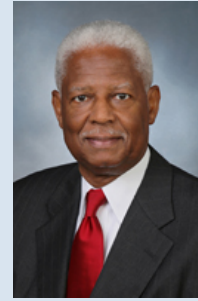
Mr. Watkins' practice also includes defending area hospitals and doctors in many cases involving claims of neuro surgical malpractice.
